

WARRANTY PROCEDURE

MARKET FARM EQUIPMENT WARRANTS THEIR MANUFACTURED PRODUCTS TO BE FROM DEFECTS IN MATERIAL AND WORKMANSHIP FOR A PERIOD OF ONE (1) YEAR AFTER THE DATE OF PURCHASE TO THE FIRST END USER AND IS SUBJECT TO THE FOLLOWING CONDITIONS.

- 1. Damage caused by improper use, negligence, or operation beyond rated capacity, improper set-up, adjustment, or any unauthorized modifications made by the dealer or customer, shall void this warranty.
- 2. Notification of damage or warranty claims must be submitted to Market Farm Equipment (M.F.E.) within seven (7) days of the date of failure.
- 3. All defective parts must be made available by the dealer, for inspection by M.F.E. if required, and returned at the dealer's expense.
- 4. All warranty claims must be approved by M.F.E.
- 5. The labour and freight required to replace defective parts is not reimbursable.
- 6. Exchange, credit or warranty status will be based on the results of the inspection of damaged items by the manufacturer.
- 7. Credit will be issued if and when the warranty claim is approved and <u>MUST NOT</u> be deducted from the account by the dealer.
- 8. Products and/or parts not manufactured by M.F.E. are subject to their own manufacturer's warranty conditions.

WARRANTY CONSIDERATION IS ONLY VALID WHEN THE WARRANTY REGISTRATION FORM HAS BEEN RECEIVED BY MARKET FARM EQUIPMENT.

This warranty does not cover a component which fails, malfunctions or is damaged as a result of (I) improper modification or repair, (II) accident, abuse or improper use, including loading beyond the specified maximum weights and requirements (III) improper or insufficient maintenance, or (IV) normal wear and tear.

THIS WARRANTY IS EXPRESSLY IN LIEU OF ALL OTHER WARRANTIES OR CONDITIONS, EXPRESS, IMPLIED OR STATUTORY, INCLUDING ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.

In no way shall Market Farm Equipment Limited be liable for special, direct, incidental or consequential damages of any kind, including but not limited to labour charges.

The exclusive remedy under this warranty shall be repair or replacement of the defective component at Market Farm Equipment Limited's option. SAFETY INSTRUCTIONS

The MARKET COMPACT CULTIVATOR is designed for tilling soil and should not be used to transport material, equipment or persons.

Do not use while under the influence of alcohol, medication or drugs.

This equipment should not be operated by children or persons who are unfamiliar with the MARKET COMPACT CULTIVATOR.

It may be necessary to add weight to the front of the tractor for the MARKET COMPACT CULTIVATOR to work properly.

Stop engine and remove key when attaching or detaching the MARKET COMPACT CULTIVATOR from the tractor.

YOUR SAFETY IS OUR MAIN CONCERN, HOWEVER IT IS UP TO THE OPERATOR TO PRACTICE CAUTION.

ASSEMBLY INSTRUCTIONS

Unpack and inspect the product for damage and/or missing parts. Please refer to the parts diagram for proper names and quantities of components.

Set Frame on a sturdy set of work horses or blocks at least 24" high.

Attach A-Frame Arms to the Frame using the Cat.1 Hitch Pins. Secure with lock washers and nuts but do not tighten.

Attach Braces to the Frame using the ½" x 1½" bolts and lock nuts. Do not tighten.

Attach A-Frame to the Braces (with Spacer between Braces) with the ½" x 4" bolt and lock nut.

Finish Frame assembly by tightening all nuts and bolts.

Please refer to the S-Tine spacing diagrams.

Attach Reversible Points to the S-Tines with the 3/8" x 1½" carriage bolts, lock washers and nuts. Tighten all nuts.

Position Clamps on Frame and insert the S-Tines. Secure with ½" x 3" bolts and lock nuts. Tighten all nuts.

OPERATING INSTRUCTIONS

Lower the MARKET COMPACT CULTIVATOR to the ground and slowly drive forward while moving the depth control on the tractor until the s-tines are approximately 3"-4" in the soil. Set the depth control stop to this position. Check that the Frame is level. Adjust the top link accordingly.


With the proper depth and speed the s-tines will move independently, vibrating back and forth as well as side to side producing a viable seed bed.



Pictures show A-Frame and Brace assembly with Cat 1. Hitch pins as well as the S-Tines & clamps.


